ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation and commencement
2. Amendment of Cap. 43:08 (Sub. Leg.)
3. Amendment of Schedule to the Regulations

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 1) Regulations, 2020, and shall come into operation on 21st April, 2020. Citation and commencement

2. Regulation 3 of the Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations (hereinafter referred to as “the Regulations”) is amended by substituting for — Amendment of Cap. 43:08 (Sub. Leg.)

(a) paragraph (c), the following new paragraph —

- “(c) at any place not specified in the first column of the said Schedule, the petroleum product at the head of the —
- (i) second column of the Schedule at a price exceeding by more than 76.634 thebe per litre;
 - (ii) third column of the Schedule at a price exceeding by more than 76.634 thebe per litre;
 - (iii) fourth column of the Schedule at a price exceeding by more than 76.634 thebe per litre;
 - (iv) fifth column of the Schedule at a price exceeding by more than 76.634 thebe per litre; the price at which the product was delivered to him.”; and

(b) paragraph (d), the following new paragraph —

- “(d) at any place specified in the first column of the Schedule, petroleum products specified at the head of the second, third, fourth and fifth column of the Schedule at an amount exceeding 65.287 thebe per litre, which amount shall be the oil industry margin.”.

3. The Regulations are amended by substituting for the Schedule thereto, the following new Schedule — Amendment of Schedule to the Regulations
