ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation and commencement
2. Amendment of Cap. 43:08 (Sub. Leg.)

IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 1) Regulations, 2023, and shall come into force on 13th January, 2023. Citation and commencement
2. The Regulations are amended by substituting, for the Schedule thereto, the following new Schedule — Amendment of Schedule to Cap. 43:08 (Sub. Leg.)

VALUE ADDED TAX (DECREASE IN RATE OF TAX) ORDER, 2023
(Published on 13th January, 2023)

ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

1. Citation
2. Decrease in rate of tax

IN EXERCISE of the powers conferred on the Minister of Finance by section 78 (1) of the Value Added Tax Act, the following Order is hereby made —

- Decrease in
rate of tax
- 1.** This Order may be cited as the Value Added Tax (Decrease in Rate of Tax) Order, 2023.
 - 2.** The rate of value added tax payable in terms of section 7 (1) of the Value Added Tax Act is hereby reduced from 14% per cent to 12% per cent with effect from 3rd February, 2023 to 31st March, 2023.
